



FARRM Rules and Code of Conduct

As a visitor to FARRM, I acknowledge that I understand and will observe the following behavioral standards. Further, I understand that failure to adhere to these standards may result in me being asked to leave FARRM property.

1. Confirmation of number of individuals visiting FARRM is required. Please confirm the number of people who will be attending FARRM **on the morning of the event.**
2. Hand-feeding FARRM animals is strictly prohibited. Large animals (**especially pigs**) can be incredibly food aggressive and as a result they may bite.
3. Entering the pig enclosures with food is strictly prohibited. As stated above, pigs are very food motivated and very strong; failure to comply with this rule could result in injury.
4. If you or any member of your party are bitten or injured in any way, seek out the owner of FARRM (Melissa Foley), or a FARRM designate **IMMEDIATELY.**
5. Please **be mindful of all gates and doors**, and ensure they are **securely** shut behind you when you are entering or leaving a space. They are there for a reason; not all of our animals interact freely with each other (or people), and they are all meant to be in specifically designated areas on the property. An animal escaping could result in serious injury to animals/people.
6. Children under the age of 12 will not be left unattended **at any time.**
7. Keep in mind that although these animals have been well socialized and domesticated, they are still livestock and interact differently than other animals you may normally spend time with, so they should be approached and handled as such.
8. FARRM is a vegan environment and we ask visitors mindfully observe and respect this choice while on FARRM property. Meat products are prohibited while on FARRM property.

WAIVER OF LIABILITY
WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration of my presence at Farm Animal Rescue and Rehoming Movement (FARRM) property, RR2, Gwynne AB, CANADA, TOC 1L0, I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE FARRM, their officers, agents, or employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in such activity, while in, on or upon the premises where the activities are being conducted, REGARDLESS OF WHETHER SUCH LOSS IS CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise and regardless of whether such liability arises in tort, contract, strict liability, or otherwise, to the fullest extent allowed by law

2. I am fully aware of the risks and hazards connected with the activities of FARRM and I am aware that such activities include the risk of injury and even death, and I hereby elect to voluntarily participate in said activities, knowing that the activities may be hazardous to my property and me. I understand that Goucher does not require me to participate in this activity. I voluntarily assume full responsibility for any risks of loss, property damage, or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of being engaged in such an activities, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES or otherwise, to the fullest extent allowed by law.

3. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage, or costs, including court costs and attorneys' fees that Releases may incur due to my participation in said activities, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise, to the fullest extent allowed by law.

4. It is my express intent that this Waiver and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE the above-named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of Province of Alberta and that any mediation, suit, or other proceeding must be filed or entered into only in Alberta and the federal or provincial courts of Alberta. Any portion of this document deemed unlawful or unenforceable is severable and shall be stricken without any effect on the enforceability of the remaining provisions.

IN SIGNING THIS AGREEMENT, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Wavier of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Agreement for full, adequate and complete consideration fully intending to be bound by same.
